All players are required to register with the England Roller Hockey. Registration with England Roller Hockey is compulsory before a player is able to train after 3 weeks or take part in any tournaments. The NRHA registration fee covers insurance for players and officials whilst participating in the game of roller hockey. Note the player must not reach the age by the end of the season 31st August e.g. under 15 age group must not be 15 in the current season.

New players to the sport need to register with England Roller Hockey as a **non-competitor** after 3 weeks.

If they decide to continue after 30 days they must register, as a **competitor** in the appropriate age group and will receive a 50% discount on this **first** registration with **England Roller Hockey**.
